Dear parent,
Hope this circular finds you in good health.

We are aware that COVID-19 Pandemic is shaking the world. Earlier there were only few cases in Buraimi, but now the situation is getting worse since the past few days. SMC is very well concerned about the difficulties and problems faced by the parents. Many people are forced to shut down their business and some have even turned jobless. This has turned the situation worse and has affected the financial graph of every individual as well as our school's.

Hence, school has stopped its working to control the spread of the pandemic as per the Ministry of Health guidelines. We have initiated online classes, considering our children's studies. These classes have pretty difficulties in the beginning but will surely get adjusted and enjoyed by students in this digital era.

It took 8 years to get affiliation status for our school, our school is climbing its steps to development. So, in this case it is difficult to reduce the number of staffs and moreover it is difficult to predict how many students will discontinue in the coming years.

School's development and progress is our superior aim. School is looking forward for your cooperation and support ahead.

Please be informed the following points:

As per the BOD decision we made the changes in the fee structure and the same is attached to this circular.

The concession offered in the annual fee (approximately R.O – 7 per month for four months) is for all the parents, irrespective of the COVID -19 effect on their economic status.

The concession offered in the tuition fee (R.O - 5 for KG-I and II) (R.O – 6 for classes I to X) is mainly intended to offer to those parents who got financially effected due to covid-19, and hence I request all those parents, who are financially not effected, to refrain from availing the tuition fee concession.

The amount paid by the generous parents (by not availing the tuition fee concession) will be utilized to help the needy parents of our school.

The parents who already paid quarterly fee would also be eligible for fee concession and the concession amount would be adjusted in the next term/month fee. (any parent in this category wants to donate the concession in tuition fee to school, may inform the same to the school office)

The above-mentioned concessions would be applicable only when you pay the fee with in 60 days i.e. the fee of April should be paid on or before 31st of May, the fee of May should be paid on or before 30th of June and so on.

As per the decision of the BOD, if any parent confirmed COVID – 19 positive, their children who are studying in our school will be given 50 % concession on tuition fee.

In this academic year 2020-21, we are not going to have usual summer break, instead we will provide a short break (around a week) at the end of June and hence our online classes will continue in the months of June and July.

A vacation of around 30 days will be given in the month of December.

Online classes will be suspended for all the classes from Friday, 22nd May to Saturday, 30th May and online classes will resume on 31st May.

President and members of SMC, Principal and staff wish you in advance "A VERY HAPPY EID".
